REQUEST FOR PROPOSALS FOR MODIFIED DESIGN BUILD SERVICES FOR THE DIVISION OF HEALTH AND SOCIAL SERVICES – MORIAH HEALTH CENTER

The Urban Development Corporation of Trinidad and Tobago Limited (UDeCOTT) invites suitably qualified design builders to provide modified design build services for the required work at the Moriah Health Center in Tobago. These services will be procured using contracts as defined in the FIDIC Conditions of Contract Plant and Design Build (General Conditions and Particular Conditions) Yellow Book.

Proponents will be required to demonstrate experience in the performance of similar works as defined by the Request for Proposal (RFP).

The successful proponent will be chosen using a qualification selection process as set out in the Request for Proposal (RFP), a copy of which may be purchased at UDeCOTT's Head Office, First Floor, 38 – 40 Sackville Street, Port-of-Spain and UDeCOTT's Tobago Office at Unit 7&8 Block A, Level 3, NIB Mall, Scarborough Tobago from October 10th, 2012 to October 12th, 2012 between the hours 8:30 am to 4:00 pm for a non-refundable fee of TT\$500.00 (Cash or Certified Cheque).

Proponents will be invited to attend a pre-submission information session at UDeCOTT's Head Office in Tobago. This information session will be conducted on October 15th, 2012 commencing at 10.00 am, after which there will be a site visit. Proponents are advised that submissions must include ALL mandatory documents as set forth in the RFP. Failure to do so may result in disqualification.

All proposals must be submitted in accordance with the terms of the RFP at the address listed below, no later than 2:00 pm on December 14th, 2012. Proposals received after the required tender submittal time will not be eligible for consideration. UDeCOTT reserves the right to reject any or all proposals.

Submissions must be deposited at the 1st Floor, UDeCOTT Building, 38 – 40 Sackville Street, Port-of-Spain in the tender box labelled:

The size of the opening in the tender box is 406mm x 50mm and submittals MUST be able to pass through this opening. Proponents must accurately sign the Tender Submittal Form located on the Tender Box.
