REQUEST FOR PROPOSALS FOR THE MODIFIED DESIGN-BUILD-EQUIP SERVICES OF THE MATHURA, MATELOT AND MANZANILLA POLICE STATIONS

These services will be procured using contracts as defined in the FIDIC Conditions of Contract for Plant and Design-Build for Electrical and Mechanical Plant and for Building and Engineering Works Designed by the Contractor (Yellow Book) for the General Conditions.

The successful Proponent for each project will be chosen using a competitive selection process as set out in the Request for Proposals. The only acceptable forms of payment are Cash or Manager's cheque.

Proponents will be required to demonstrate experience in the provision of similar services as defined by the RFP. Proponents are advised that submissions must include ALL the documents as set forth in the RFP. Failure to do so may result in disqualification.

All proposals must be submitted in accordance with the terms of the RFPs at the address listed below no later than 2:00 pm (EST) on September 17th, 2013. Proposals received after the required tender submission time will not be eligible for consideration. UDeCOTT reserves the right to reject any or all proposals.

Submissions, completed and labeled in accordance with the instructions contained in each RFP, must be deposited at 1st Floor, UDeCOTT Building, at the address below in the appropriately labeled tender boxes.
