## **EXPRESSIONS OF INTEREST** TO OBTAIN A VENDOR LICENSE FOR THE RENTAL OF BEACH PARAPHERNALIA AT THE MARACAS BEACH FACILITY

The Urban Development Corporation of Trinidad and Tobago Limited, (UDeCOTT) invites interested individuals to submit Expressions of Interest (EOIs) to obtain a vendor license for the rental of beach paraphernalia at the Maracas Beach Facility.

The Maracas Beach Facility is a thriving economic zone where entrepreneurs can earn an income by working on the beach.

In keeping with policy of regulating and regularizing vending on the beach, UDeCOTT takes this opportunity to remind all persons who wish to engage in the rental of beach paraphernalia, including but limited to beach chairs at the Maracas Beach Facility that they must first obtain a license permitting them to do so.

All licensed beach vendors will be easily identifiable through the wearing of polo shirts bearing the stipulated beach vending logo on the front left breast, and the words "Beach Vendor" written across the back. Licensed beach vendors will be issued and required to carry identification cards when working on the beach.

New programmatic initiatives are designed to make licensed beach vendors easily visible and identifiable to all patrons who utilize the Maracas Beach Facility, to remove previous stigmas and to allow people to recognize and appreciate that licensed beach vendors not only provide a valuable service but are also entrepreneurs who must be afforded the opportunity to capitalize on the tourism industry.

Each Respondent must include an original and one (1) copy of the EOI, for submission at the address listed below, no later than <u>2:00 p.m.</u> (EST) on August 9, 2019. Submissions received after the stipulated deadline would not be eligible for consideration. Submissions must be deposited at 1<sup>st</sup> Floor, UDeCOTT Head Office, 38-40 Sackville Street, Port of Spain, in the appropriately labelled tender box.

## **INSTRUCTIONS FOR PURCHASE OF EOI PACKAGE**

- A complete set of documents comprising the EOI Package may be purchased by making a non-refundable deposit of <u>TT\$750 VAT Inclusive, to</u> <u>UDeCOTT's Account #852948 at any branch</u> of First Citizens Bank Limited, via Cash or Manager's Cheque.
- (ii) Upon making this deposit, the EOI Package may then be collected at UDeCOTT's Head Office 1<sup>st</sup> Floor, 38-40 Sackville Street, Port of Spain via hard copy or electronically, upon request, between the hours of <u>9:00 a.m.</u> (EST) to <u>4:00 p.m.</u> (EST), from <u>July 29 to August 8, 2019</u> (excluding weekends and public holidays), by presenting proof of payment, being the stamped deposit receipt from the bank. The EOI Package will NOT be available for collection after this deadline.
- (iii) **Deadline date for submission is** no later than **<u>2:00 p.m.</u> (EST) on August 9, 2019.**
