#### 1. What is the purpose of this Request for Proposal?

The purpose of this Request for Proposal is to identify and contract a suitably qualified and experienced Contractor with the necessary resources to undertake the following work packages:

Package 1- Foundation Works Package 2- Plumbing and Fire Protection Installation Package 3- Electrical Installation Works Package 4- Air Conditioning and Ventilation System

#### 2. Are there any eligibility requirements for this Procurement Process?

In order to be eligible for evaluation and/or consideration to provide the Services for **Packages 1 & 4** the Proponent must be able to demonstrate the following:

- 1. Submission of receipt for the purchase of the RFP package;
- Three (3) projects of a similar nature in the last 10 years valued TT2M, with at least (1) project using Trinidad and Tobago Institute of Architects Stand Building Contract (With Quantities) 2013 based on joint Contracts Tribunal(JCT) Standard Building Contract (With Quantities) 2005 as condition of Contract
- 3. Independently Audited Financial Statements (for companies) and Accountant's Reports (for partnerships and sole proprietors only) for 2014, 2015 and 2016 prepared in accordance with International Financial Reporting Standards or any other such internationally accepted accounting standards (For Joint Ventures, each member MUST meet this requirement) which clearly identify the individual financial position of the Proponent.
- 4. Certificate of Registration, Incorporation (and Certificate of Continuance, where applicable);
- 5. Valid Statutory Documents inclusive of Income Tax and VAT Clearance Certificates and National Insurance Board Compliance Certificate;
- 6. Firms must submit all documents and information as required by the RFP.

In order to be eligible for evaluation and/or consideration to provide the Services for **Packages 2 & 3** the Proponent must be able to demonstrate the following:

- Independently Audited Financial Statements (for companies) and Accountant's Reports (for partnerships and sole proprietors only) for 2014, 2015 and 2016 Audited financial statements for 2014, 2015 and 2016 <u>or</u> Management accounts for 2014, 2015 and 2016 (for VAT-registered entities) <u>or</u> Banker's Letter (for non-VAT registered entities only
- 4. Certificate of Registration, Incorporation (and Certificate of Continuance, where applicable);
- 5. Valid Statutory Documents inclusive of Income Tax and VAT Clearance Certificates and National Insurance Board Compliance Certificate;
- 6. Firms must submit all documents and information as required by the RFP.

#### 5. What is the recommended team composition?

At a minimum, the proposed team should comprise the following:

- 2. Civil/Structural Engineer;

- 3. Site Supervisor- MEP(Full Time

- 2. Electrical Engineer
- 3. Site Supervisor- MEP(Full Time)

#### What experience is the Proponent required to demonstrate?

#### Package – 1

Proponents are required to demonstrate that its key human resources assigned to the team have provided similar works on at least two (2) completed projects of a similar nature of a value of at least TT\$2M.

Similar projects is defined as follows:

- I. Provision of Construction services (Civil/Building Works) (e.g. Commercial buildings at least two storey, foundations of two storey buildings no less than 7500sq.ft. earthworks).
- II. Projects for which the construction cost exceeded TT2M, in which the Proponent has provided construction services.

#### Package-2

Proponents are required to demonstrate that its key human resources assigned to the team have provided similar works on at least two (2) completed projects of a similar nature value of at least TTD\$45,000.00.

Similar projects is defined as follows:

- I. Provision of Plumbing and Fire Services (e.g. Installation of plumbing and fire lines, piping, pumps, tanks).
- II. Projects for which the construction cost exceeded (TTDS 45,000.00).

#### Package-3

Proponents are required to demonstrate that its key human resources assigned to the team have provided similar works on at least two (2) completed projects of a similar nature value of at least TTD\$20,000.00.

Similar projects is defined as follows:

- I. Provision of Electrical Services (e.g. Electrical Installation in two storey commercial buildings).
- II. Projects for which the services cost exceeded (TTDS 20,000.00).



# FREQUENTLY ASKED QUESTIONS (FAQs)

## Expansion Works at the Emperor Valley Zoo

#### Package-4

Proponents are required to demonstrate that its key human resources assigned to the team have provided similar works on at least two (2) completed projects of a similar nature value of at least TTD\$1.5M.

Similar projects is defined as follows:

- I. Provision of Air Conditioning and Ventilation System Services (e.g. two storey commercial buildings).
- II. Projects for which the construction cost exceeded (TTD\$1.5M).

Proponents are to note that the responses provided as guidance to these Frequently Asked Questions does not relieve the Proponent of its obligation and responsibility to fulfill and comply with all requirements of the Request for Proposal.
